\*Subcontractor Category: Any person, partnership or corporation or other entity engaged in construction and who furnishes labor, or labor and materials used in the construction of projects, pursuant to contracts with persons or entities other than project owners. The term "labor" shall include shop labor for the manufacture or fabrication of specific materials to be installed in a particular construction project; or labor on a jobsite that is managed by the subcontractor.

\*\*Associate Category: Any person, partnership or corporation or other entity engaged in construction who does not fit the definition of a Subcontractor as listed above. Architects, engineering, general contracting, construction owners, and construction management are not eligible for membership.

**NOTE: Members in the Associate category will be billed the same amount for membership dues as those in the Subcontractor category after completion of their first year of membership (i.e. membership renewal after initial year joined).**
