The term "labor" shall include shop labor for the manufacture or fabrication of specific materials to be installed in a particular construction project; or labor on a jobsite that is managed by the subcontractor.

^{**}Associate Category: Any person, partnership or corporation or other entity engaged in construction who does not fit the definition of a Subcontractor as listed above. Architects, engineering, general contracting, construction owners, and construction management are not eligible for membership.
